VISTOR COMMENTS:

MARK HAFFNER: Mr. Haffner asked if there were any updates on the fence situation.

LYNN CLEVELAND: Mr. Cleveland wanted to confirm that the elections for the Volunteer Police Officer Memorial Fund had taken place. He was told that they had.

LAURIE ROHRBACH: Mrs. Rohrbach is the health insurance administrator for the Township. She reported that it's time to renew the health insurance for 2019. There will be a 7% increase in the cost for the same plan. After reviewing several options with the insurance carrier, it appears that keeping the current plan is in the best interest of the Township.

The health insurance company is also adding a "Call-A-Doc" option. This is available to all employees and elected officials. It is at no cost to the Township, but does cost the employee \$5 per month. It is designed to reduce ER and Urgent Care visits and costs.

RESOLUTION 2018-43 – A RESOLUTION TO APPROVE THE 7.1% INCREASE IN THE COST OF THE HEALTH CARE PLAN AND THE ADOPTION OF THE \$5.00 PER MONTH PLAN was introduced by Mark Cross and seconded by Abra Reed.
