EXECUTIVE SESSION:

 Mrs. Reed made a MOTION, seconded by Mr. Stubbs, to adjourn into Executive Session to consider the appointment of a public official under the authority of ORC 121.22 (G)(1). The vote was a follows: Mrs. Reed – YES; Mr. Stubbs – YES. The Trustees entered Executive Session at 2:04 pm.

- The Trustees held discussion under the authority of ORC 121.22(G)(1) to consider the appointment of a public official.
- At 3:50 pm Chief Joe Andzik entered the Executive Session, leaving at 3:52 pm.
- Mrs. Reed made a MOTION, seconded by Mr. Stubbs, to reconvene into Regular Session. The MOTION PASSED. The Trustees reconvened into Regular Session at 4:13 pm.

DISCUSSION ON THE APPOINTMENT OF A TRUSTEE:

- Mrs. Reed thanked everyone for coming and staying through the Trustees' long Executive
 Session. She reported that the Trustees did their best and considered all applicants but could
 not come to an agreement. She noted that the process will move forward with the "Committee
 of Five" that former Trustee Matt Burns named on his election petition to represent him.
- Mr. Stubbs acknowledged that he and Mrs. Reed have had their public disagreements recently. He felt that today's process was fair and under control. He hopes that moving forward they can do the right things for the Township. He thinks it's in the best interest of the Township to have the Committee make the appointment.
- Mrs. Reed agreed with Mr. Stubbs. The Executive Session was very constructive and they put forth a lot of effort to review all candidates. It was not a haphazard process.
