ZONING & TRASH COLLECTION REPORT -

Mrs. Rohrbach presented a-listing of Waste Collection accounts that are more than \$100.00 delinquent and requested a resolution to assess the property owners for the amounts as listed on the attached spreadsheet. She also noted that the delinquent notices have been sent out as required by ORC.

RESOLUTION 2010-43, a Resolution to authorize the assessment of property owners who are delinquent as to waste disposal service charges pursuant to Ohio Revised Code Section 505.33, was introduced by Mr. Hanahan, seconded by Mr. DeGroat, at the Regular Board of Trustees Meeting on September 13, 2010.

WHEREAS, the German Township Board of Trustees established a solid waste collection and disposal district for the unincorporated area of German Township by Resolution 98-04 on January 12, 1998 pursuant to Ohio Revised Code Sections 505.27 & 505.28, and;

WHEREAS, the German Township Board of Trustees contracted for waste removal pursuant to Ohio Revised Code Section 505.27 and established a fee for waste disposal service to be invoiced to all owners of improved property within the unincorporated areas of German Township, and;

WHEREAS, each owner of improved property was invoiced quarterly for this waste removal, and;

WHEREAS, each owner of improved property is delinquent on their waste disposal service charges in excess of \$100.00, as listed on the attached spreadsheet; and were notified on Sept. 1, 2010, by certified mail, to pay the delinquent amounts or assessment of these delinquent charges for waste disposal service would be placed on their property tax duplicate for collection, pursuant to Ohio Revised Code Section 505.33.

NOW, THEREFORE, THE GERMAN TOWNSHIP BOARD OF TRUSTEES, MONTGOMERY COUNTY, HEREBY RESOLVES:

SECTION 1: That the Board has reviewed and certifies the attached listing of owners of improved property and descriptions of their lands, as delinquent as to waste disposal service charges by more then twelve months, and;

SECTION 2: Request that the Montgomery County Auditor place the charges as listed on the attached owners listing on the tax duplicates for collection.

III. Mrs. Rohrbach presented a draft resolution approving Rumpke contract with the Western Regional Council of Governments and setting the monthly fee for German Township.

RESOLUTION 2010-44, A resolution introduced by Mr. DeGroat, seconded by Mr. Hanahan, to accept the contract between the Western Regional Council of Governments and Rumpke Waste as provider of solid waste removal for German Township and to establish the rate for service as described below; during the Regular Board meeting of German Township held on September 13, 2010.

WHEREAS, The German Township Board of Trustees of German Township, Montgomery County, State of Ohio, has by unanimous vote, agreed to allow Western Regional Council of Governments (W.R.C.G.) to accept bids for the collection and disposal of residential solid waste within said District.

WHEREAS, a contract will be entered into with a private hauler, through competitive bidding, for the collection and disposal of residential solid waste within said District with an equitable charge being paid for the use and benefit of such service by every person whose premises are so served, the charges to be kept in a separate fund and appropriated and administered by the Board of Trustees.

NOW THEREFORE BE IT REOLVED, that the Township Board of Trustees of German Township, Montgomery County, State of Ohio:

SECTION 1: Accept the contract between WRGC and Rumpke Waste as the provider of solid waste removal for German township;

SECTION 2: Authorize all expenses incorporated in this contract to be invoiced to the appropriate individual property owner; with the addition of the current administrative fee, effective October 1, 2010.

The adoption Vote was as follows: Mr. Benson - Yes, Mr. DeGroat - Yes, Mr. Hanahan - Yes; RESOLUTION 2010-44 passed.
